## Derating Curve:



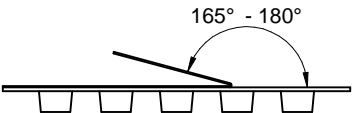




