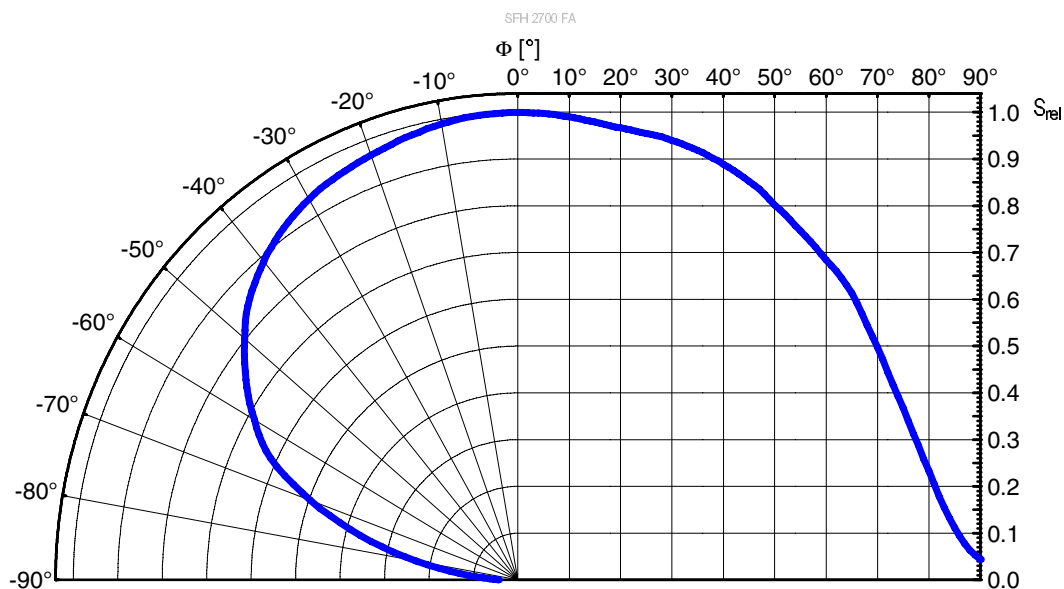

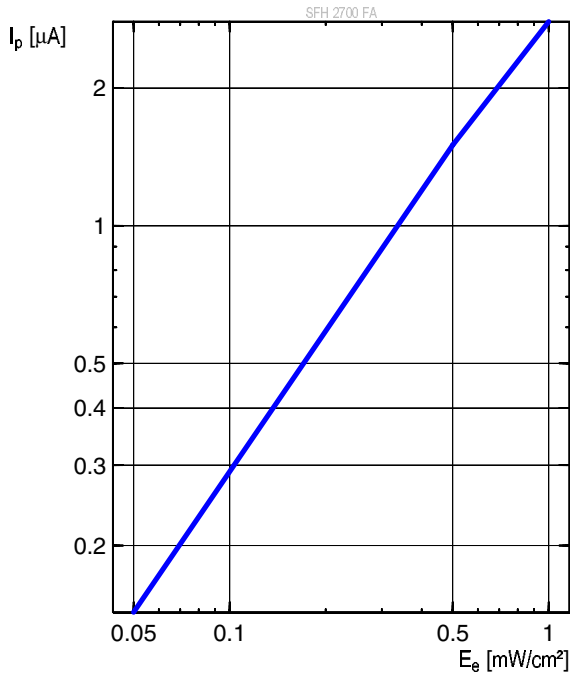

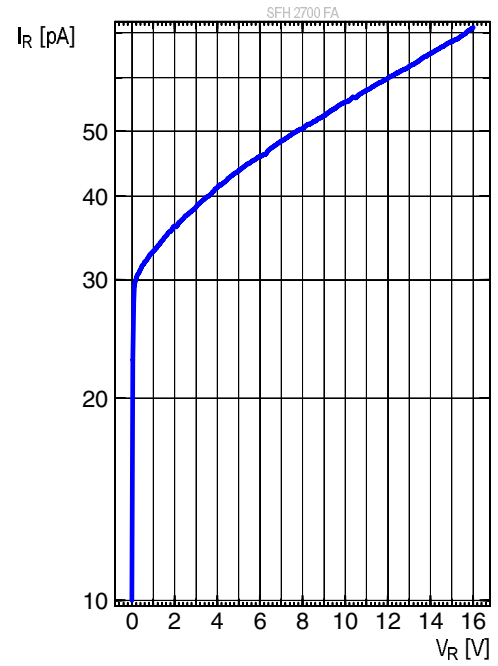

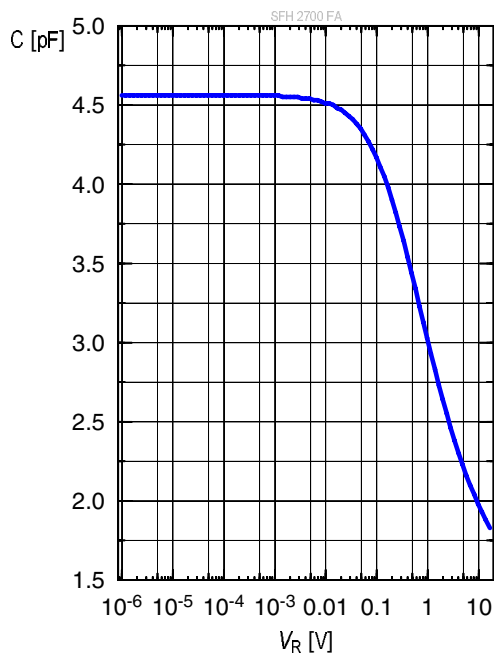

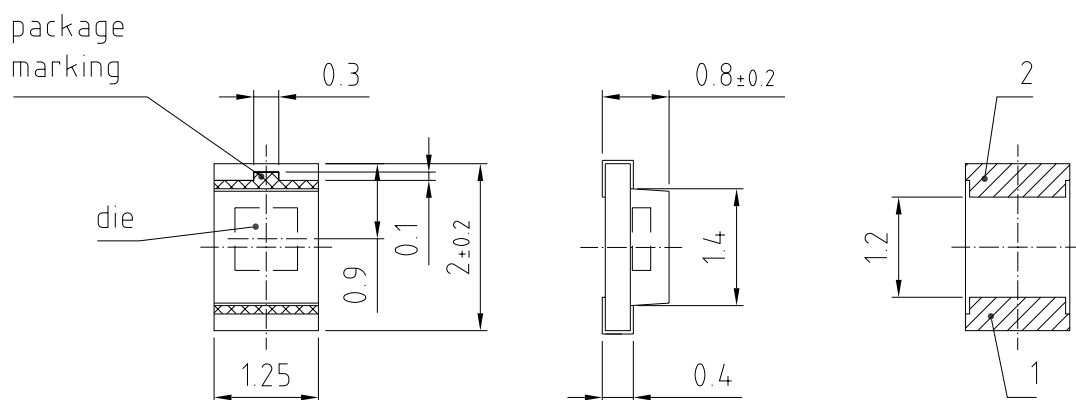

## Dimensional Drawing <sup>3)</sup>



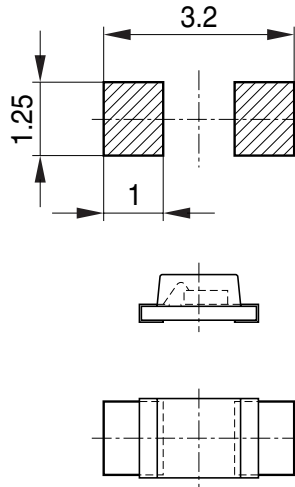

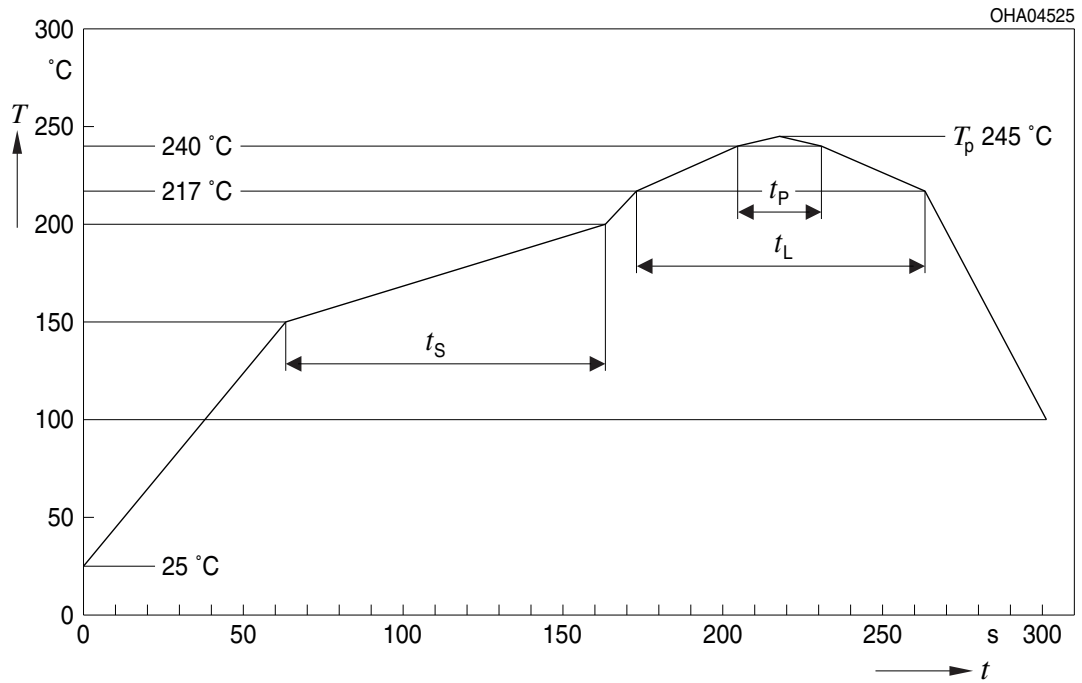

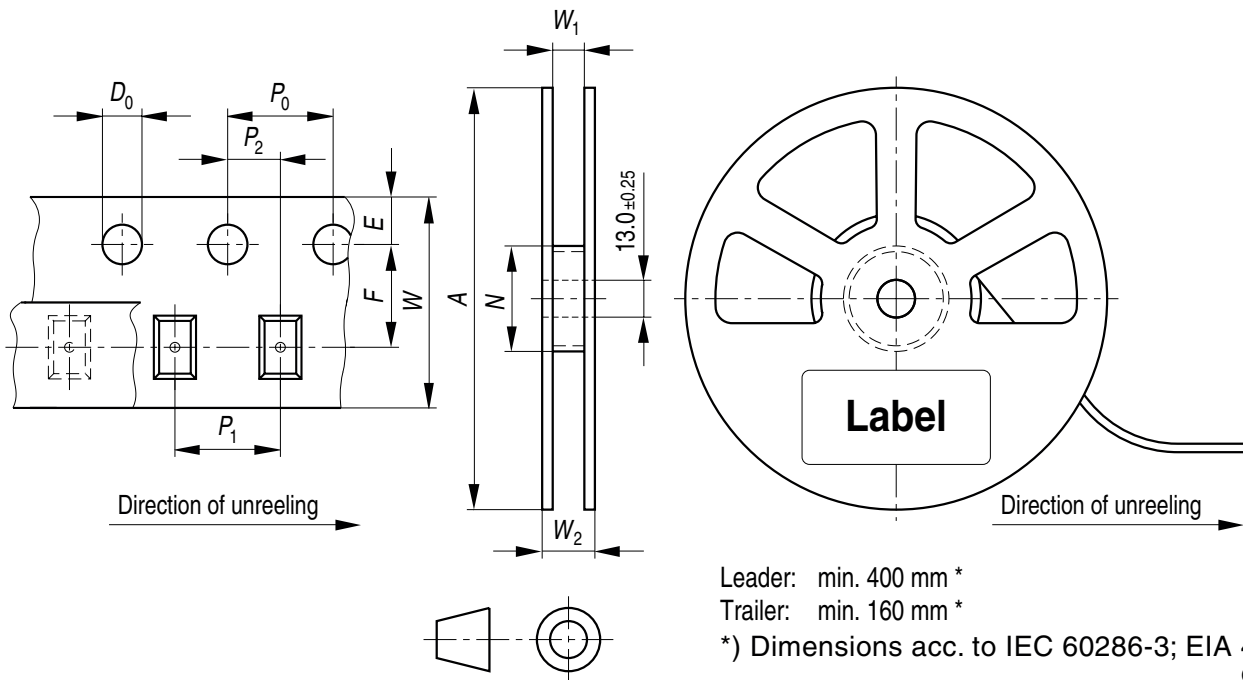

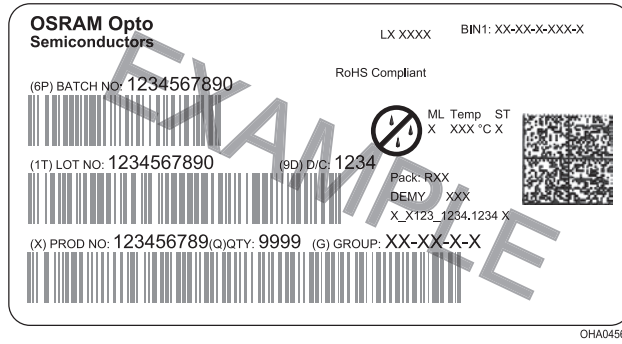

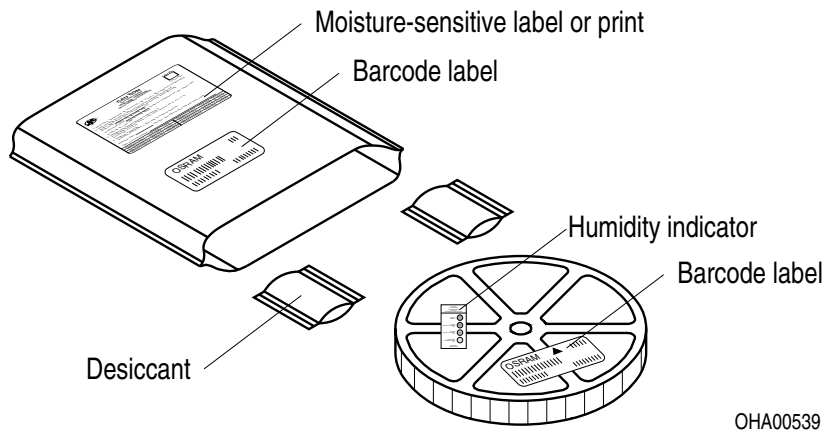

## Barcode-Product-Label (BPL)

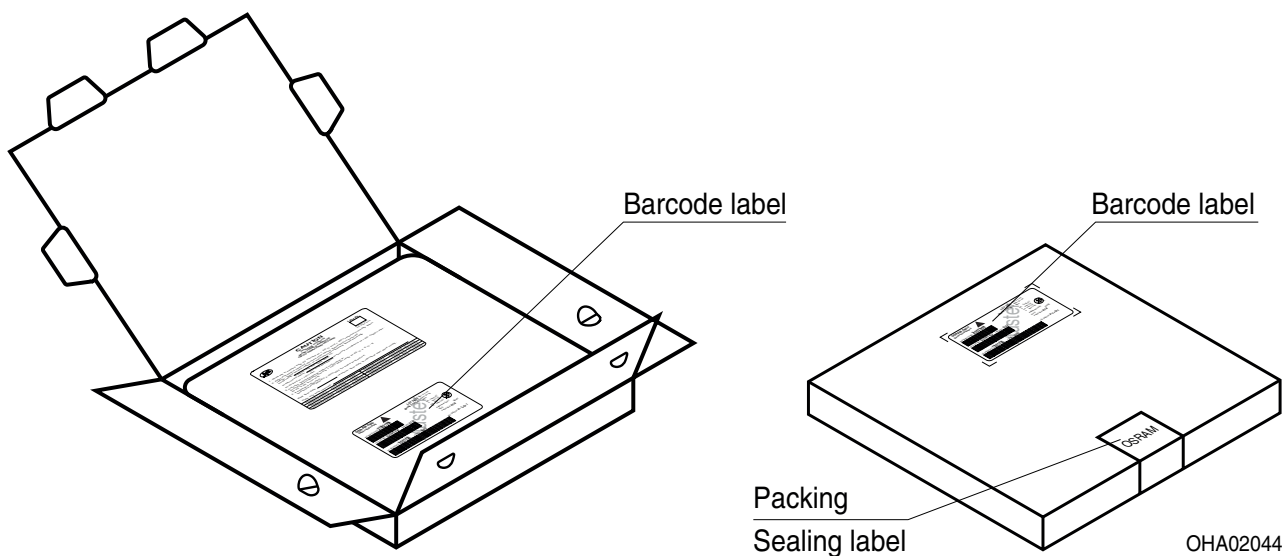


## Dry Packing Process and Materials <sup>3)</sup>

## Notes
