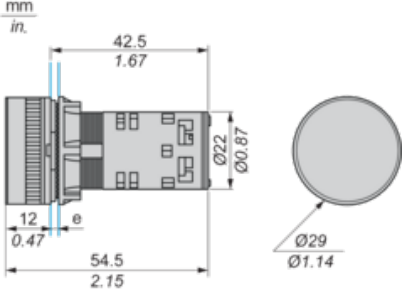

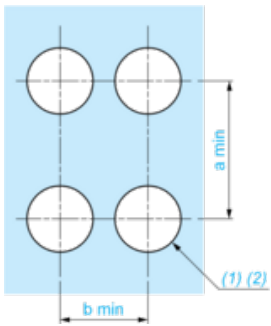

Connection by Screw Clamp Terminals

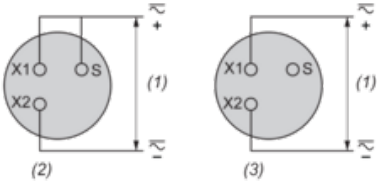
