The HL6354MG/55MG are 0.63  $\mu$ m band AlGaInP laser diodes with a multi-quantum well (MQW) structure. They are suitable as light sources for laser levelers, laser scanners and optical equipment for measurement.






#### **Typical Characteristic Curves**
