### Classification of the substance or mixture:

#### **Classification (DPD):**

#### Engineering controls:

Extraction is necessary to remove fumes evolved during reflow.

Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. Ensure good ventilation/extraction.

In case of dust formation, we recommend wearing of appropriate respiratory protection equipment with particle filter P. This recommendation should be matched to local conditions.
